1. ORGANISING SAILING CLUB

2. VENUE AND SCHEDULE

The regatta will take place on the waterfront of the sailing club, with the following schedule:

A total number of 9 races are scheduled. A maximum number of three races may be sailed on any one racing day. On 25 of August, last time for the warning signal for the last race will be 4.30pm.

3. RULES

The regatta will be governed by the rules as defined in the Racing Rules of Sailing 2009-2012. In case of conflict between rules in the notice of race and the sailing instruction, the sailing instruction will take precedence. For infraction to rules of part 2 of RRS Rules 44.1 e 44.2 will be changed so that two-turn penalty is replaced by one –Turn Penalty.

In case of conflict between languages, the Italian text will prevail. Sailing Instruction will be available from 10 a.m. of August 30, 2012.

4. ELIGIBILITY

The championship is "open". Italians and foreigner competitors may enter and shall comply with ISAF Eligibility Code, Regulation 19, Section B RRS.

Competitors must be **member of A Class National Association** and have a valid **medical certificate**

Competitors shall carry a current and valid **third Party Insurance certificate**, to cover damages To objects and persons for an amount not less than € 1.000.000,00 as fixed by FIV rules.

5.1 PRE-REGISTRATION

Pre-registration is mandatory and the dead line **31 July**. Competitors may register sending Name and Sail Number by e-mail, fax to CVAT the Organizing Sailing Club.

5.2 REGISTRATION

Entry form duly filled by competitors together with proof of entry fee payment, shall be forwarded by e-mail or fax **no later than July 31st**.

At check-in competitors are requested to present the original documents.

6. ENTRY FEE

Entry Fee is amounting to **€ 100,00**.

Copy of receipt shall be presented at the registration.

7. MEASUREMENT

Rule 78 RRS will apply. Each boat shall produce a valid measurement certificate at registration. All boats with a measurement certificate issued after January, 1st 2010 shall have ISAF plaques affixed to the starboard transom. Measurement and equipment inspection will be conducted. Mast and sail admitted will have the stamp of the chief measurer. Competitors may only use one sail and mast. In the event of damage that is not feasible to repair the competitor must obtain written permission from the Race Committee. Inspection may be conducted at any time during the regatta.

8. SCORING

The low point scoring system of Rule 90.3 RRS and Appendix A will apply.

- 4 races must be completed to constitute the Italian Championship, and no discard will apply.

- when 5 to 8 races have been completed, a boat series score will be the total of her score excluding her worse score. Thus amending Rules A2,

Appendix A RRS. - when 9 races have been completed, a boat's series score will be the total of her race score excluding her two worst score.

Regatta will be considered valid with any number of races made.

9. PRIZES

The first three participants will be awarded in the general ranking list, the first woman and the first Junior. The Italian Champion will be the first competitor of Italian Nationality.

10. ADVERTISING

Advertising code as regulation 20RRS ISAF shall apply. The event is classified under C category.

11. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4 decision to race. The organizing sailing club, will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, or after the regatta.

12. PHOTOGRAPHY AND IMAGEG TV CONSENT

Competitors accept that they may be photographed and or video-taped in the race and/or using the regatta facilities, and they consent to the use, re-use, publication and re-publication of such images in any media in conjunction with competitor's name or not without compensation and without the competitor's approval of such images or any use thereof
